No unforeseen difficulties arose apart from going over budget slightly though this was tackled by self finance to meet the difference.

-Has helped highlight and gain an understanding of the conservation value of PKNP as well as gain a better understanding of the threats posed.

-Has helped develop recommendations to deal with threats and a zoning plan for future management plus given assistance to future proposals dealing with conservation and livelihoods in PKNP.

-Has helped develop local capacity and relations with the park authorities.

**4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).**

Local guides and local transport were employed when ever possible and food and basic field equipment was sourced as locally as possible.

**5. Are there any plans to continue this work?**

Yes, have recently been awarded part funding from MBZ species conservation fund to survey status and distribution of primates with in PKNP which would not have been possible without the results gained from Rufford.

**6. How do you plan to share the results of your work with others?**

A full report in English and Khmer will be distributed to all relevant parties and partners working in Siem Reap province plus the Ministry of Environment Cambodia. In addition international Conservation NGOs working in Cambodia will receive a copy of final report.

**7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?**

The RSG grant was used for over 7 month's field work, 2 months write up and 1 month preparation. Total 10 months which was approximately the anticipated project length.
