There was overspending on the field operation specifically for when rescuing the tiger and associated logistical costs. The team had to find alternative sources of funding. Overall this project was successful and resulted in a positive impact for tiger conservation in Sumatra

3. Briefly describe the three most important outcomes of your project.

The important outcomes are:

1. SRI created the Tiger & Wildlife Response Unit and 10 months ago changed the name to the Wildlife Rescue Program Unit (WRU) by Sumatra Rainforest Institute (SRI). The programme is recognised at the national level as the most active NGO for Sumatran tiger protection including for mitigating and handling the Sumatran tiger-human conflict, and sumatran tiger rescue from illegal trapping.
2. Involved in creating the the Strategy and Action Plan Conservation for the Sumatran Tiger 2018-2028. SRI was invited and involved in regional and national meetings including field experiences and giving ideas for the 10 years national programme of Sumatran tiger conservation in Indonesia
3. Batang Gadis National Park ecosystem, Batangtoru forest ecosystem and Dolok Surungan forest ecosystem is also listed as priority tiger habitat in the north Sumatra province in the draft document of the Strategy and Action Plan Conservation for the Sumatran Tiger 2018-2028

4. Briefly describe the involvement of local communities and how they have benefited from the project (if relevant).

Local communities were involved in many field activities including the WRU team is ready 24 hours a day and the local communities feel like they benefit from this project.

5. Are there any plans to continue this work?

1. SRI will continue the mitigating and response of the human-Sumatran tiger conflicts around the Batang Gadis National Park area and add the Batangtoru forest at next round project implementation in north Sumatra province.
2. To continue the campaign and awareness about Sumatran tiger conservation among the local communities around Batang Gadis National Park and Batangtoru forest
