A website has been developed with information on white storks, and the birds of the Sava region. Due to technical characteristics and increase in the price of software development regarding a responsive application, currently the app was replaced by a mobile responsive web site, and activities regarding mobile app will be continued in the future.

**2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).**

In May 2014 catastrophic floods have hit Bosnia and Herzegovina, including the Municipality of Gradiska where the project activities took place. Because of this fact certain project activities, such as the installation of white stork nest carriers and field activities regarding the bird census, have been temporarily postponed. Despite this, in the later stage of the project all of the planned activities were fully implemented with high quality.

Another problem that the project team faced is the increase of the market price in Bosnia and Herzegovina for the development of the mobile app, which was caused by high technical specification, the amount of data and the responsiveness of the app itself. Due to this, the project team has decided to develop a mobile responsive web site, which can be used on mobile devices as well. In addition, the international SpringAlive ([www.springalive.net/world](http://www.springalive.net/world)) campaign was used during 2014 to promote the results of the project and to assist us during the bird species identification within the local community.

### **3. Briefly describe the three most important outcomes of your project.**

Main outcome of the project are:

- 1. Yearly report of monitoring of the white stork** – report was part of Bosnia and Herzegovina national report to BirdLife International.
- 2. Protected white stork nests** - The nests are protected on the electric poles by setting up carriers (instalment of four nest carriers). This will lead to reducing the number of injured young.
- 3. Report on first bird census along Sava River** - Between May 2014 and April 2015 research on a monthly basis was made in order to collect data about birds in that region, as well as to provide recommendations for the conservation. Based on available data, so far it's obvious that Sava floodplains are playing key role during bird's spring and autumn migrations. The aim of the research was to collect data on birds diversity of the area, their distribution, potential threats and to determine next steps in this long-term vision for conservation of bird's and their habitats. During the research, 54 bird species were recorded and are listed. Some of them are common and widely spread, but certain number of species e.g. storks (white and black), golden oriole, Montagu's harrier, night heron, hawfinch, etc.

### **4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).**

At the very activity of monitoring, local residents addressed to us with the new information on the field and it they directly helped us in locating the nests.

For second time in last 3 years, a special contribution of involvement with the local community is also an involvement of the Electric Distribution Company, which recognised the importance of protecting the white storks. In coordination with Electric Distribution Company we worked on the identification of the nest for protection. Set the nest carriers were carried out by Electric Distribution Company.

### **5. Are there any plans to continue this work?**

We plan to continue with promoting and raising awareness among local population about the importance of preserving biodiversity and natural habitats, and where we will put special attention on the development of eco-tourism and bird watching.

The further work on the development of the web site as a promotion and information sharing tools will be continued as well as the work on the development of the mobile app. We will insist on the popularisation and continue to promote the River Sava as an attractive biological and ornithological destination.

### **6. How do you plan to share the results of your work with others?**

All our activities are promoted through local media and, our website and social media. Our monitoring results are regularly sent to the national network for tracking white storks in the territory of Bosnia and Herzegovina. Also, as a part of the project, publications were made and distributed to the local population.

**7. Timescale: Over what period was the RSG used? How does this compare to the anticipated or actual length of the project?**

The project lasted for the period April 2014 - April 2015.

Certain deviations of the original project activities timeframe appeared in the first part of the project implementation due to the devastating floods which hit Bosnia and Herzegovina in May 2014. This largely influenced the implementation of the field activities, and it was necessary to invest additional financial funds to cover the longer period of field activities implementation. These additional funds were obtained from our own resources and invested in the project.

**9. Looking ahead, what do you feel are the important next steps?**

It will be necessary to maintain a continuous monitoring of white stork population, as regular activities in our community.

As part of our future plans, we find it important to present and promote birdwatching tourism in the region, as a potential solution for the protection of biodiversity and preservation of natural habitats.

It is also necessary to additionally promote River Sava, and its floodplains as tourist attractions within the region.

It will be necessary to directly involve the local population in the bird watching and monitoring activities in the upcoming period in order to raise awareness of the local population in a more interactive way. One of the ways to do this is to provide basic infrastructure for birdwatching and ecotourism, such as observation points, small boats and basic technical equipment.

One of the main target groups regarding promotion in the upcoming period will be elementary school students. The birdwatching activities will serve as an extra curriculum activities or as a form of outdoor class.
