To know the contribution of CF in controlling forest fire.			х	Most of the interviewee expressed drastic reduction of fire occasion especially in community forests. It was also evident from the records maintained in the field offices.
Document the increase/drop of awareness level of the user group in forest fire.			X	Field survey conducted across 12 community forests revelled that all the members are aware of forest fire and its ill effects both environment and health. With the establishment of community forest and decentralisation of the forest management in the villages more people are aware and developed a sense of ownership.
Know the Forest fire control measures undertaken in the CF.			X	In most of the community forest site visit indicted that fire lines are being constructed and appointed fire watcher on rotation basis for fire control measures. Moreover, they have communication net work in case of fire outbreaks with their mobile numbers shared among them and made compulsory for all members to join fire fighting. They also have fines and penalties in place in case of apprehending the culprit and for those fail to join the fire fighting.
To know the contingent recovery measures for rehabilitating the damaged area in case of fire out breaks.		X		Community forest members do carry out rehabilitation works, like plantation in burnt area, but it's found that they are unable to carry plantation in all areas of burnt at once, due to the lack of resources, technicality of members and other constraints. However, they do preventive measures before fire, like awareness among members, seek help from relevant agencies.

During the pretesting of the questionnaires same interviewees were invited to take part in the final interview, however, in most of the site due to the unavailability of the same person, different person have to be interviewed from the same forest management group. The team have to explain from the beginning the purpose of the interview, objectives and all. However, the survey went well although we have to deal with new person.
