## 2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

During the development of the process there was only one difficulty. This was the difficult situation of public order in the region, which led to the postponement of the socialisation of the research project for December. However, the research project was sent in physical and digital, pending the presentation for the end of the year to the indigenous communities.

#### 3. Briefly describe the three most important outcomes of your project.

The purpose of this work was to contribute to the discussion in the construction of agreements for the conservation, use and management of biological and cultural diversity of protected areas within the framework of joint management between indigenous peoples and the Colombian Government, taking as case study The Yaigojé Apaporis Park Reserve, with a view to providing conceptual elements to a new relationship model that reinforces the protection and strengthening mechanisms of the territory, since the role of local communities doesn't always coincide with the institutions responsible for conservation and exercise of environmental authority.

From a process of characterisation of facts in the defense, protection and strengthening of the territory, together with the evaluation of variables associated with the resilience and identification of the social learning elements of these events



that led to the management agreement between ACIYA - Association of Indian Captains of Yaigojé Apaporis- and Parques Nacionales for the constitution of a PNN - Natural National Park -, the discussions and reflections of the research were centered. Within a qualitative and descriptive analysis, it was observed that the knowledge systems, the creation of the reserve, the formation of ACIYA, the extension of the reserve and the constitution of the PNN Yaigojé Apaporis were the most outstanding events on the part of the indigenous peoples of the Apaporis base to defend, protect and strengthen the territory against mining and external threats.

The shamanic and cultural aspects of territorial management restructure the learning, the social participation and the polycentric governance as variables to develop resilience in this type of events for the defense, protection and strengthening of the territory. The vision of the local communities on the integrality of the territory turned out to be the starting point to understand the complexities inherent to the management of the protected area in order to articulate the different visions and territorial logics. The learning and recommendations of this work will contribute to the consolidation of the local communities and their traditional authorities, and Parques Nacionales Naturales de Colombia around the joint management of the Yaigojé Apaporis Park Reserve.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

Local communities participated in the methodological development of data collection within the research project. These spaces of exchange of knowledges were the semi structured interviews and the community workshops.

On the other hand, the communities saw or will benefit from linking the results of this research project to the construction of the management plan (REM) of the Yaigojé Apaporis Park Reserve. In addition, it strengthens the coordination and decision-making exercise between ACIYA, as an indigenous authority, and Parques Nacionales as an environmental authority in the co-management.

#### 5. Are there any plans to continue this work?

Yes, there are. Now, I am working with Parques Nacionales in the field of knowledge management of the protected areas of the Colombian Amazon. The idea is to generate information on the approach of the work with the work done in the topic of governance with indigenous communities for the conservation and use of biodiversity. Likewise, show the case of Yaigojé, as it is a key example of coordination between the Colombian state and the indigenous.

#### 6. How do you plan to share the results of your work with others?

In the first instance, share the document of the research project with the actors that interact with the Yaigojé Apaporis Reserve Park in the territory. These are governmental and non-governmental entities. And as a second instance, publish the research project in some scientific magazine to make the subject more visible.



## 7. Timescale: Over what period was The Rufford Foundation grant used? How does this compare to the anticipated or actual length of the project?

The Rufford Foundation grant was used during April and September 2016 where the field visit was made. Still pending the socialization of the results of the research project with the indigenous communities in the territory. It is expected to carry out this activity at the end of the year at the congress of traditional authorities. Likewise with Parques Nacionales in an own space.

The anticipated or actual length of the project, it can be said that the proposed values corresponded to the project execution phase. The only thing that changed was the time of socialisation of the results due to the time to do the same, since these dates depend on the local communities, not the researcher.
