2. Please explain any unforeseen difficulties that arose during the project and how these were tackled.

During the project, the only unforeseen difficulty that I faced was the language barrier in the Tachileik survey. However, it can be conducted easily with the help of Tachileik CSO members. Apart of this, most people in three selected cities, Yangon, Mandalay and Tachileik, do not want to answer questions related to wildlife consumption. However, I can solve easily as I have local team members from each city as well as they took keen interest in collecting information and they know very well how to get the information from others. Also, I hired the local informants from each city if needed. Slightly delay for interview surveys during COVID-19 pandemics.

3. Briefly describe the three most important outcomes of your project.

According to the project results, following are three most important outcomes,

1. Current status of wildlife consumption in three selected cities are clearly identified.
2. Classified which wildlife species were included in wildlife consumption such as food, medicine, ornaments and pets.

3. Share information on wildlife consumption with not only government departments but also non-government organisations regarding combating illegal wildlife trade in Myanmar.

4. Briefly describe the involvement of local communities and how they have benefitted from the project.

Local communities were involved as the survey respondents. However, based on the outcomes of the project, wildlife conservation activities and public awareness programme could be extended to include local communities in and around the study sites.

5. Are there any plans to continue this work?

Yes, I plan to conduct the public awareness programmes such as training, education talks and campaigns in Yangon, Mandalay and Tachileik based on the outcomes of this project. Moreover, I am planning to continue extending wildlife trade and wildlife consumption surveys in Tanintharyi Region, the southern part of Myanmar where information gap on wildlife trade surveys. It is my intention to apply for a 2nd Booster Grant.

6. How do you plan to share the results of your work with others?

I have a plan to publish in the peer reviewed journal which will help to reach more audiences. Besides, I plan to share my findings to law enforcement agencies and non-governmental organisations working on combating the illegal wildlife trade. Moreover, will provide to academic institutions for references and government departments to integrate in wildlife conservation strategies.
