Presentation of the investigation in indexed scientific papers				Having in mind that the work has been delayed for several reasons, the writing of these papers has also been delayed, hope to have this ready and published by the end of 2019.



2. Please explain any unforeseen difficulties that arose during the project and how these were tackled (if relevant).

The worst difficulty we encountered during the project was that during a second fieldwork we were invited to the Vaupes River by the end of February, to better understand the fishing management through the region, our friend and leader of the expedition, the ichthyologist and Professor Javier Maldonado drowned in the river while we were doing some work; obviously this expedition did not conclude.

During the fieldwork in Tiquie, we suffered a big difficulty, which was that we got stolen around \$ 375 GBP that we never recovered. I had to replace this money, which was to pay for logistics during the fieldwork, from my own.

The final product of this work, which is my master's degree thesis, has been delayed because of personal problems, regarding my mom's health, an extension for the due date was given by my university to the end of June. That's the main reason this final report has been delayed. Right now everything is ok with my mom's health.

3. Briefly describe the three most important outcomes of your project.

The most important outcome for me was the fact that we could leave a local team with the capacity and tools to make local investigation possible as well as the creation of audio-visual tools.

The understanding of all the issues and problematics regarding the fish resources and the creation of the basis for a proposal for the management and monitory of this resource.

The empowering of local communities regarding the use and management of their natural resources and territories, through the empowering of individuals.

4. Briefly describe the involvement of local communities and how they have benefitted from the project (if relevant).

The involvement of the local communities was one of the most important aspects of this work. The AATIZOT association was involved in all the phases of this project.

The main objective of this project was to contribute with the management of the fish resource in the Tiquie region. This is the reason why this project was built from the bottom up, this meaning it was built with the communities, having in mind their needs and ways of understanding and looking at the world.

The direct benefit for the communities has been the empowering of locals in acquiring investigation and audiovisual tools for their internal work. As well as the solid base to generate the resource management plan for the fisheries in the zone. Thanks to this project and to donations made by Idea Wild we could leave a camera, laptop, PC, voice recorder and a GPS for the communities to use.



5. Are there any plans to continue this work?

Yes, currently we have several projects that we are building with the different communities in Colombian Tiquie as well as in the Vaupes region looking to keep empowering these communities and contributing with the conservation of the rich biological and cultural diversity present in this area.

One of the proposal that arose from this work, was to contribute with the fisheries in the zone by creating nurseries and/or fish culture systems to take some pressure off from the natural fish stocks and populations.

We are also working in one of these communities in building an ethno-education project managed by the community.

For the Vaupes region near Mitu which is the capital city for this state, we are currently working in a social-economic project involving the distribution of several indigenous and Amazon products such as chili pepper, essential oils from the jungle and crafts from some indigenous communities, looking to generate some additional income for the families that leave nearby Mitu. With these families and their communities, we are also planning to start building some communitarian tourism process in the zone.

6. How do you plan to share the results of your work with others?

In July 2019 I plan to visit the area to present the work to the communities and to the people from the Colombian Tiquie River. This will be the first place and moment these results will be shared.

By August 2019 I have to present the results of this project to my University (INPA in Brazil) so, I can have my master's degree in protected areas management.

We hope that by that time, the fishing documentary will be ready and we can start sharing it through many different channels such as social media, internet, different film festivals, city gatherings, etc.

I hope to have ready and published two scientific articles by the end of 2019 relating this investigation. In addition, my plan is to show the investigation in different symposiums and congresses.

7. Timescale: Over what period was The Rufford Foundation grant used? How does this compare to the anticipated or actual length of the project?

Mostly all of the Rufford Foundation grant was used during a 3-month period, which coincided, with the 1st month of planning and the 2 prior months of field work which was the most cost expensive phase of the project, this where July, August and September.

This was a small fraction in time of the project having in mind that after this two more fieldwork phases where included and funded by other means, and the



analysis and written part of the project is still going until the end of this month. As well as the post-production of the documentary.

Right now the important next steps to follow are primarily to finish my thesis and master's degree, while these is being done I aim to finish the two scientific articles to be published in peer reviewed journals.

It's important to start presenting the work done in different places such as symposiums, academic congresses, academic gatherings, internet, social media, etc.

It is also important to continue the empowering and accompaniment process that we have been working with this communities so we can have a bigger impact.

It is also very important to continue with the communication and divulgation process we have been working to keep creating awareness about conservation processes worldwide.

At this moment, the logo of the Rufford Foundation has not been used yet, but we will surely include it in the fishing documentary we are producing and plan to have ready by July, as well as in all the video capsules we will be producing and sharing through social media. In addition, the logo is going to be in my thesis presentation and other presentations regarding this investigation.

The completion of this work has been delayed, in part due to personal reasons regarding my mom's health; this is why I had not sent anything yet, because I wanted to send this report with my thesis and the documentary ready.
