The Covid-19 Pandemic and the resulting government measures to contain the spread locally and nationally made it difficult from March 2020 to access the forest areas. However, we were already completing activities under this grant and commencing activities in another grant cycle generously provided by other organisations.

- 3. Increased public awareness of conservation at the governmental level, local communities and even amongst average citizens in the area

The local communities were involved in the project as they were engaged as key stakeholders providing inputs for cooperation across sectors and resource users and locals also benefitted from employment opportunities available in the project particularly in transport and field activities.

5. Are there any plans to continue this work?

We are already continuing this work, thanks to the support from Whitley Fund for Nature and National Geographic Society. We will both increase our current efforts while also initiating formal and active protection of the conservation area.

6. How do you plan to share the results of your work with others?

We have shared some of the results of this work through news articles in Mongabay.com, BBC Environment, African Primate journal and other informal platforms. We still hope to share more widely using available multimedia e.g. radio and television interviews including scientific journals.

The grant was used from August 2019 – April 2020 and anticipated period was from August 2019 – May 2020.
