## 2. Please explain any unforeseen difficulties that arose during the project and how these were tackled.

Movement restrictions, lockdowns and other covid19 related complications have added logistical and other challenges and continue to do so. However, although I now have some catching up to do, I am confident all my planned raptor road surveys will be complete by October this year. Hopefully I will be able to then spend time in Cape Town at the University there as planned to complete my master's Thesis. I could not carry out a planned activity with one of the communities I engage with as initially planned. Instead of a bush trip with the Zutshwa community, I could only give a verbal presentation which lasted for only a few hours, in honour of following protocol.

#### 3. Briefly describe the three most important outcomes of your project.

- 1. Growing interest and passion for raptors among communities living in wildlife management areas. When I started having meetings with communities to discuss and share knowledge about raptors, there has been growing interest and eagerness to learn more about these species, and especially how to protect them. The local people want to be educated about these species and how they can co-exist safely with them, they want more opportunities where they learn about their wildlife, so that they're able to expand their knowledge and be able to protect their wildlife using it.
- 2. Conducting this project has also been immensely helpful for my professional growth. With my knowledge of raptors and their importance in the ecosystem, I am awarded opportunities to impart my knowledge to various people, including students at different levels, primary to tertiary levels. As well as to government officials and other various stakeholders. I have had opportunities to present to students and other stakeholders about the role of raptors and vultures in the environment, the increasing need to protect them from the various threats they face including poisoning.
- 3. Although not a large part of my project, I had the incredible opportunity to be part of the Raptors Botswana team which introduced vulture safe zones in the country. With more practice and time allowance, we hope I can be able to take weight of this initiative independently that is, without a whole team to do the job, I can be able to do so on my own.

## 4. Briefly describe the involvement of local communities and how they have benefitted from the project.

The Zutshwa and Ngwatle communities that are involved in this project have welcomed it with open arms and are very much eager to keep learning and being



involved in the protection of raptor species in their areas. As much as these communities reside in wildlife management areas (WMAs), they have extraordinarily little experience of the bush/wild and most of the people here have never encountered wild animals. This project has helped them change this, we had an instance were post covid-19, we had a bush trip with the Ngwatle community. In this trip the local people were exposed to the wild for the fist time ever, this trip was also important to put visuals to these "raptor species" that need protecting as we always teach them. This way, locals could really appreciate nature and be one with it, from their own personal experiences instead of through someone else's words, as is usually the case. Unfortunately, we could not do the same with Zutshwa community due to covid-19 restrictions, but instead had regular verbal presentations with them.

#### 5. Are there any plans to continue this work?

The project is not yet complete, so yes, I would like to complete it, to also complete my studies.

#### 6. How do you plan to share the results of your work with others?

Once the project is complete, I will publish my findings, and share them with various stakeholders and government departments/officials.

The grant was spent over a period of 16 months. I plan to have completed my overall project by October 2022.
