to determine the abundance and distribution of the Tarucas and identify key habitat for conservation				Seven field trips were made in both, Caspalá and Santa Ana locality, so we were able to sample the proposed sites. We recorded a total of 50 Tarucas in addition to obtaining the records of faeces, footprints and antlers, and from these data we made maps and identified sites of importance for the specie. With the information collected, a technical report and a scientific publication will be produced. Once the publications are made, they will be sent to the Rufford Foundation website.
Involve local communities in conservation of Tarucas				Two workshops were held with the participation of Santa Ana and Caspalá local communities. In these workshops, information was provided on the legal protection of the species, and local people provided information on areas with the presence of Tarucas and main threat factors. Printed educational material was delivered during these workshops. The active participation of the two municipal commissions of both towns and the Association of tourist guides was achieved.
Education awareness				Two signs with information on the species and on the legal protection were designed, printed and set in places selected by the local communities. Signs were placed with the participation of local tourism guides from both localities. Educational material with key information about the species was designed and printed. We decided to elaborate posters with information



	about the Taruca instead of making brochures. This decision was made after meeting the local communities,
	so it was considered that the posters are more attractive to people,
	achieving greater scope in the dissemination of information.
	Interviews were given on radio and TV
	and an article was published in a provincial newspaper.

2. Please explain any unforeseen difficulties that arose during the project and how these were tackled.

There were no major difficulties in the development of the proposed objectives. Only the Covid-19 pandemic that sometimes delayed the trips to visit the two localities.

3. Briefly describe the three most important outcomes of your project.

- Surveys of tarucas: an estimate of the number of Tarucas was achieved in each of the two localities. This was of great importance to generate a baseline to monitor the success of the actions carried out to improve the status of the species. In addition, we were able to identify areas with the presence of the species.
- 2. Involvement of local communities in the conservation of the Taruca: Through the workshops with the community, it was possible to know their perception of the Taruca. In turn, we ensure that they know the current conservation status to be able to work together in management and conservation actions. In addition, they provided very important information on areas with the presence of Tarucas and the main threats and provided logistical support in the field work since they acted as guides and provided horses to carry the equipment.
- 3. Education and collaboration with other institutions: Posters were designed and placed, and dissemination material was designed and printed. Through the awareness-raising material, the community was able to show interest in learning more about the Taruca. Participation in the project was achieved by technicians from the Jujuy province environment ministry and the National Park Administration. Local tour guides got involved in the project and participated in the workshops.

4. What do you consider to be the most significant achievement of this work?

5. Briefly describe the involvement of local communities and how they have benefitted from the project.

The communities of Santa Ana and Caspalá were key in the development of this project. In the event of talks and workshops, they actively participated showing



interest in acquiring new knowledge about the conservation status of the Tarucas and the provincial and national protection laws. They also shared their previous knowledge about the places where we can find them and other relevant information about the Tarucas in their habitat and the role they play. In addition, there was the participation of community members to disseminate the project and as guides in the search for Tarucas in the field.

6. Are there any plans to continue this work?

Yes, this project generated basic information on the abundance of Tarucas in the towns of Santa Ana and Caspalá. There are plans to continue this work reinforcing the sampling effort at the same sites and increasing other places where we are aware of the presence of Tarucas.

7. How do you plan to share the results of your work with others?

The results will be published through scientific articles, talks in schools, universities, national parks, social networks, radio and TV. This will allow the exchange of knowledge and an expansion of the project. They will also be available on the CEBio Foundation website: www.cebio.org.ar and on social media.

8. Timescale: Over what period was the grant used? How does this compare to the anticipated or actual length of the project?

This grant was used from January to December 2021. It was postponed a couple of months from what was originally proposed due to restrictions due to the Covid-19 pandemic.
