1. Executive Summary

Preliminary community engagement and mapping exercises were successfully completed, setting the stage for the core activity implementation Quarter 2.

2. Key Achievements This Quarter

Bilateral meetings were held with the Local Authority administration and their specialized wildlife departments. Key insights were collected that inform project planning and implementation.	Completed

An in-depth assessment was done in collaboration with the local Authority- Mbire RDC to select the most suitable implementation ward. - Land Preparation : Identify and prepare suitable plots for chili cultivation in ward 2.
- Farmer Training on Sustainable Cultivation Techniques: The team will provide training sessions for farmers on sustainable practices, such as organic pest control, crop rotation, water-efficient irrigation methods, and organic fertilization to promote soil health.
- Distribution of Seeds and Resources : We will supply quality chili seeds and necessary agricultural inputs (such as organic fertilizers and tools) to participating farmers, ensuring equitable distribution and accessibility.
- Workshops on how to make chilli bombs
